THE NEW TURNER, GUILFORD, KNIGHT CORRECTIONAL CENTER

On April 17, 1989, Metro Dade opened its new 1,000 bed jail, the Turner, Guilford, Knight Correctional Center (TGK), to alleviate the overcrowding in its correctional system. We toured this facility. The Metro Dade Correctional Department is distinctly proud of this "third generation" facility. In addition to being an evidently pleasant and accommodating facility, they argue that jails of this type are more cost effective to operate than traditional "first generation" jails. Unfortunately, we remain unconvinced that the construction and furnishing costs of such a facility are warranted. The living conditions of the TGK Center are strikingly superior to the other jails we visited. Each inmate is provided with an individual room, desk, chair and commode. Each pod is equipped with four televisions, a ping-pong table, private visiting rooms, exercise equipment and a basketball court. While no one advocates medieval conditions, college dormitories do not provide as comfortable an environment as does the TGK Center.

Children, elderly and the homeless needing health and human services, drug addicts and their families requiring counseling and those living in unsafe, deteriorated housing all desperately seek Dade County tax dollars to deal with their problems. At the TGK Center, individuals charged with or convicted of a crime will have access to services and living conditions beyond the attainment of many law-abiding citizens. Simply put, to most people, this does not seem either fair or proper.

But we think the County can justify the expense involved by using this new facility to create more in-jail programs which break the cycle of arrest, release and rearrest. The new center provides a golden opportunity to provide drug treatment aimed at reducing crime fueled by drug addiction. Recent urinalysis studies indicate that at least 80% of arrestees booked through the Dade County Jail have drugs in their system.

We applaud the County's recent decision to expand its existing drug treatment capability from 80 to 200 inmates. The "pod" structure of the TGK Center is perfectly designed for use as a therapeutic environment, and we hope that an even greater number of inmates will be treated.

Treatment experts have indicated that to provide drug treatment with a counseling staff 7 days a week, 12 hours a day within a jail facility can cost as little as \$8 to \$10 per day per inmate. This represents a significant savings when compared to \$60 a day in a community residential treatment facility. Since the main costs of an institution are already provided, the counseling staff is the sole additional cost. Citizens understand and appreciate financial spending which is aimed at breaking the cycle of drugs and crime.

However, in order to provide effective rehabilitation programs an inmate must be incarcerated long enough to benefit from the program. Thus, it makes sense to place convicted offenders with potential to benefit from rehabilitation in a treatment program in the TGK Center, for a specified period of time.

The Florida Department of Corrections faces an overcrowding crisis. In contrast, Dade County has attempted to keep pace with the increasing need for jail space and recognizes the need for effective rehabilitation programs. Even as the TGK Center opens, the County has begun planning for additional jail space. Dade County recognizes that building jails and developing programs are both necessary. Every effort should be made to utilize the TGK Center to its fullest potential as part of this overall effort.

GRAND JURY SERVICE

Few problems have been so repeatedly addressed by successive Dade County Grand Juries as have the issues of the inadequate number of Grand Jurors permitted to serve and their meager per diem pay. Like lonely voices in the wilderness, eight Grand Juries since 1978 have urged the Legislature to increase the number of jurors permitted to serve and increase compensation in an effort to make the Grand Jury service less onerous. The Legislature has failed to respond to these pleas.

The existing statutory number of Grand Jurors creates an unreasonable burden on those who serve. The 18 members of the Grand Jury are subject to the same perils and problems which are a part of everyone's daily existence. During a six month term people become ill, move away, die, leave town on business, marry, or have relatives who become ill, need surgery or die. Over the years, these circumstances have caused the simultaneous absence of several jurors making it impossible to obtain a quorum to conduct official business. Such situations have created lengthy delays, postponements or, as in one extreme case, required a grand juror to appear on an ambulance stretcher.

Dade County's Grand Jury meets every week for six months to perform its duty of reviewing our community's most serious crimes and its most serious problems. During an average term, the Dade County Grand Jury hears 70 capital homicide cases. In addition, the Grand Jury has tackled such problems as public housing, drugs, prison overcrowding and high school drop-outs. While Grand Jury service has its personal rewards, it presently remains unnecessarily burdensome, frequently inhibiting the ability of the Grand Jury to fulfill its duty as effectively as possible.

The per diem compensation paid to Grand Jurors, presently \$10 per day, is totally inadequate to compensate many who serve on the Grand Jury. Since 1978, when the buying power

of \$10 was markedly greater than it is today, pleas have been made to upgrade this barely significant payment. To the single parent, \$10 is inadequate to cover child care costs. To the owner of a small business or the independent contractor, a reimbursement of \$10 in no way comes close to easing the burden Grand Jury service imposes.

This Legislative Session presents the opportunity for the Legislature to prove its support for the mandated responsibilities of Grand Juries. Several pending bills before the Legislature call for an increase in the number of jurors serving and an increase in per diem pay. We urge the Legislature to maintain the quorum at 15 and increase the number of jurors to be impaneled from the present 18 up to 23 persons. This would allow each judicial circuit the discression to impanel between 18 and 23 jurors. We also urge the Legislature to increase the daily compensation a juror receives from \$10 to \$30 per diem. It is high time the Legislature approved these long overdue amendments in order for a Grand Jury to carry out its statutory duties and to do so effectively.
